REGISTRATION / RELEASE FORM

In consideration of the opportunity to participate in any events conducted in whole or in part for the First Choice Pregnancy Center, this runs' sponsors, directors, volunteers hereafter referred to as the RELEASED PARTIES, I on my own behalf of my participating family members, our heirs, personal representatives, successors and assigns, hereby release and hold harmless the RELEASED PARTIES from any and all claims, demands, rights and causes of action of any kind whatsoever which I/we have now or may later have against the RELEASED PARTIES in any way resulting from, arising out of, or in connection with the performance and/or involvement with/of any such event and/or from any claims that may arise from my/our participation in any event.

IN THE EVENT I MAY HAVE A MINOR (FOR WHICH I AM THE PARENT, LEGAL GUARDIAN, OR OTHERWISE RESPONSIBLE, HIS / HER / THEIR HEIRS, PERSONAL REPRESENTATIVES OR ASSIGNS) PARTICIPATE IN ANY OF THE DIAPER RUN EVENTS, ON BEHALF OF SAID MINOR, HIS / HER ESTATE, PERSONAL REPRESENTATIVE OR ASSIGNS, I HEREBY GIVE THE SAME RELEASE AS STATED IN THE ABOVE AND FOLLOWING PARAGRAPHS AS IT WOULD APPLY TO THE SAID MINOR. THIS RELEASE APPLIES TO ANY KIND OF SITUATION, WHETHER IT RELATES TO NEGLIGENCE, CONDITIONS, INSTRUCTIONS, RULES OR PROCEDURES RELATED TO THE EVENT.

I represent that I am familiar with the operation of motorcycles and voluntarily participate. I fully understand there are serious risks and dangers involved in motorcycling. In the event that I bring a minor who participates in this event, I will instruct the minor accordingly and will assume all responsibility for any losses of any kind, including death or serious bodily injury including costs, damages or personal injuries, for any such risks, known or unknown, even if caused in whole or in part, by the negligence of the released parties. Also, despite this release agreement and covenant, if I, or anyone on behalf of the minor, makes any claim against any of the release parties, I agree to indemnify and hold harmless the released parties from any kind and all claim brought against them. This means that I will be responsible for seeing that these expenses get paid. I further agreed to waive (give up) any rights that I may have by Nevada state law which might limit or avoid the scope and/ or affect of this release and indemnification agreement.
